- (3) The boundaries of the Pleasant Valley Recreation and Park District are hereby fixed pursuant to Exhibit "A" which is attached hereto and by this reference incorporated herein.
- (4) The name of said District shall be the "Pleasant Valley Recreation and Park District".

RESOLUTION CALLING AN ELECTION TO DETERMINE

WHETHER THE PLEASANT VALLEY RECREATION AND PARK

DISTRICT SHALL BE FORMED AND TO SELECT THE

ELECTIVE OFFICERS OF SUCH DISTRICT

WHEREAS, on the November 7, 1961, the Board of Supervisors of the County of Ventura, State of California at a hearing of said Board, by resolution, duly made and adopted, found and determined certain land in that area generally known as "Pleasant Valley" of the County of Ventura to be in need of a Recreation and Park District and further found, determined, and ordered that the name of said District should be the Pleasant Valley Recreation and Park District; and

WHEREAS, the boundaries of said proposed district have been determined and established, and it has been found that the formation of such a District will benefit all areas included within the boundaries so fixed, and

WHEREAS, this is the time and place for considering and adopting a resolution to call and give notice of an election to be held in the proposed District to determine whether the District shall be formed and to select the elective officers of the District, if it is formed:

NOW THEREFORE, IT IS RESOLVED AND ORDERED:

That an election shall be held and the same is hereby called to be held on January 16,1962 to determine whether a recreation and park district to be known as the Pleasant Valley Recreation and Park District

shall be formed for the purpose of providing parks and recreational facilities as provided in Sections 5780 et seq. of the Public Resources Code of the State of California, and to select the first five directors of said District.

That the Boundaries of said District shall be as set forth in Exhibit
"A" which is attached hereto and by this reference incorporated herein.

That the polling places for such election shall be opened at seven o'clock A.M. on the day of said election, and shall remain open continuously from said time until seven o'clock P.M. of the same day, when said polling places shall be closed except as provided by Section 5734 of the Elections Code of the State of California.

That the names of all individuals properly nominated according to Section 58167 of the Government Code of the State of California shall be entered on said ballot with instructions to the effect that five persons shall be elected as directors of said District, that electors may vote for five of said candidates, and that to vote for any specific candidate the elector shall stamp a cross (+) in the voting square immediately following his name.

That on the ballot to be used at said election, in addition to any other matters required by law, there shall be printed substantially the following:

MARK CROSS (+) ON BALLOT ONLY WITH RUBBER STAMP: NEVER WITH PEN OR PENCIL.

(ABSENTEE BALLOTS MAY BE MARKED WITH PEN AND INK OR PENCIL.)

#### INSTRUCTIONS TO VOTERS

To vote on any measure, stamp a cross (+) in the voting square after the word "YES" or after the word "NO". All marks, except the cross (+) are forbidden. All distinguishing marks or erasures are forbidden and make the ballot void.

If you wrongly stamp, tear, or deface this ballot, return it to the Inspector of election and obtain another.

On absent voter's ballots mark a cross (+) with pen or pencil.

A cross (+) placed in the voting square after the word "YES" in the manner hereinbefore provided shall be counted in favor of the adoption of the question or proposition. A cross (+) placed in the voting square after the word "NO" in the manner hereinbefore provided shall be counted against the adoption of the question or proposition.

DIRECTORS OF PLEASANT VALLEY RECREATION AND PARK DISTRICT (Vote for five)

A cross (+) placed in the voting square after the name of a specific candidate shall be counted in favor of election of such candidate as a Director of the Pleasant Valley Recreation and Park District, if formed.

That the precincts, polling places, and election boards for said election shall be as set forth in Exhibit "B" which is attached hereto and by this reference incorporated herein.

That the County Clerk of the County of Ventura shall canvass the returns of said election in the stead of the Board of Supervisors of

said County; the canvass shall begin as soon as the returns are in and shall be made at the usual place of meeting of said Board, to wit: in the Board of Supervisors Chambers, 5th floor, in the Court House Building of said Ventura County, situated in the City of San Buenaventura, State of California; said canvass, when begun shall be continued until completed; as soon as the result of the votes is certified by the County Clerk, the Clerk of the Board of Supervisors shall enter a statement of the result upon the records of said Board of Supervisors.

That if the proposition of forming said Recreation and Park District receives the requisite number of votes, to wit: a majority of the votes of the qualified voters voting at said election, then the Board shall enter an order to that effect upon its minutes. The Board shall also enter in its minutes the names of the five candidates receiving the largest numbers of votes for the positions of Directors of said District.

The County Clerk is hereby authorized, instructed, and directed to procure any and all official ballots, printed matter, and all supplies and paraphanalia as may be necessary, properly and lawfully, to conduct said election. He is further instructed to issue notice of election in the manner and form required by law, and to publish said notice once a week for three (3) consecutive weeks before said election in the Camarillo News, a weekly newspaper of general circulation, printed, published, and circulated within the area of the proposed District. Within ten days after the adoption of this resolution the County Clerk shall cause copies of this resolution to be posted in three public places in each election precinct.
