**All food vendors must attach a copy of their TFF or MFF Annual Permit. If you do not have an annual permit, complete the TFF-1 or TFF-2 operator application and attach a separate check for the health department. These forms are required to participate in our event.**

The Pleasant Valley Recreation and Park District will be holding the Easter Eggstravaganza & Spring Craft Fair at the Community Center Park, Saturday, March 31, 2018. To participate in this event, you must follow these instructions:

1. All items sold may be handmade or commercially purchased.
2. You must submit a photograph (Black & White or Color) of a sample of the food you intend to provide. The photo will not be returned unless you include a self-addressed stamped envelope with your completed application form. Returning vendors do not need to submit photos. Digital photos will be accepted by email to [ksimber@pvprd.org](mailto:ksimber@pvprd.org).
3. You will be assigned a space of approximately 10 feet by 10 feet for TFF and 24 x 10 for MFF. You will need to provide tables, display racks, and a canopy. All tents and canopies must be flame retardant and securely fastened to the ground by weights. There is no shade or electricity, so please bring your own.
4. **This is a non-refundable fee to cover staff and publicity costs.** The fee may be credited to a future show, should the district cancel this event. Participants should remember this is an outdoor event and will be subject to inclement weather (rain, wind, etc.). The District will close the event only under extreme weather conditions. The vendor should be aware that the District will not accept any responsibility for goods damaged due to inclement weather. The vendor must make their own decision to set up or not set up their display. **NO REFUNDS** will be made for any reason.
5. Complete the application form and mail/email it with your photographs. You may pay by check, money order, or credit card (Visa, Mastercard or American Express). If you choose to pay by credit card, you will be charged a **\$10 processing fee**. You will then receive follow-up information accepting or rejecting your application. Accepted applications will receive an information packet approximately **one week prior to the event**. The packet will contain maps, parking instructions and last-minute details.
6. Late check-in will not be accepted. Vendors must check in by 8am and stay until the conclusion of the event at 2pm.

8. **You are required to post updates as to your planned attendance at this event on your social media accounts and/or your website on Monday and Friday the week of the event.**

# Agreement, Waiver and Release

I understand the vendor fee is non-refundable. I understand this is an outdoor event and the District will not accept any responsibility for goods damaged due to inclement weather. The vendors must make their own decision to set up their display. **NO REFUNDS WILL BE MADE FOR ANY REASON.**

I have carefully read the description of the activity/event for which I/we are registering and in consideration for being permitted by the Pleasant Valley Recreation and Park District to participate in the activity/event. I hereby waive, release and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter occur to me, as a result of participation in said activity, even though that liability may arise out of negligence or carelessness on the part of the Pleasant Valley Recreation and Park District, its officers, employees, and agents. It is understood this activity involves a certain element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the Pleasant Valley Recreation and Park District, its officers, employees, and their agents free and harmless from any loss, liability damage, cost, or expense which they incur as a result of death and any injury or property damage I sustain while participating in said activity.
