I ALSO AGREE TO DEFEND, INDEMNIFY, HOLD HARMLESS, RELEASE and DISCHARGE and agree not to sue PVRPD, its officers, employees, agents and representatives (collectively, PVRPD Parties) from and against any claim for any injury, death, or damage to or loss of property arising out of, or in connection with, my and the Organization's use of the Premises from whatever cause, including the active or passive negligence of PVRPD or PVRPD Parties, or any other participant in the use of the Premises, other than an injury or damage arising out of the gross negligence or willful misconduct of PVRPD or PVRPD Parties. In consideration for being permitted to use the Premises, I hereby agree for myself, my heirs and assigns and the Organization that I/the Organization shall release, indemnify and hold harmless PVRPD and PVRPD Parties from any and all claims, demands, actions, or suits arising out of or in connection with my/the Organization's and our invitees use of the Premises.

I understand and agree that to the best of my knowledge, I have no medical, physical, mental or emotional health condition that would affect or hinder my use/occupancy of the Premises or ability to execute this Informed Consent and Release. If this application is being sought on behalf of an organization, I am duly authorized to bind the Organization to the terms of this Informed Consent and Release, and assume responsibility for the conduct and actions of all of the Organization's invitees using the Premises. I am aware that this is a full release of all liability and sign in on my own free will.

I/the Organization agree to abide by, and require our invitees to the Premises to abide by, the rules and regulations of PVRPD, the State of California and any other local ordinance or regulation that may apply to my/our use/occupancy of the Premises. I/we accept full responsibility for the conduct of those using the Premises in connection with this Activity. I have read and understand all PVRPD rules and regulations that apply to the intended use/occupancy of the Premises and understand that any failure to comply may result in cancellation of the right to use the Premises. I/we further understand that this form is only a request for a reservation and that no reservation is complete and binding until all fees and deposits are paid in full and all information requested is submitted, including a signed copy of this Agreement.
