### SOFTBALL LEAGUE - AGREEMENT, WAIVER, AND RELEASE

I understand the competitive and physical nature of the program for which I am registering and in consideration for being permitted by the Pleasant Valley Recreation and Park District to participate in the Softball Leagues, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter accrue to me, as a result of participation in said activity. This release is intended to discharge in advance the Pleasant Valley Recreation and Park District, its officers, employees, and agents from any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of the Pleasant Valley Recreation and Park District, its officers, employees, and agents. It is understood that this activity involves an element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the Pleasant Valley Recreation and Park District, its officers, employees and agents free and harmless from any loss, liability, damage, cost, or expense which they incur as the result of my death or injury or property damage that I may sustain while participating in said activity.

**CONSENT AND RELEASE FOR MAKING AND USE OF VIDEO TAPE/PHOTOGRAPH FOR PRINT AND INTERNET USE:** In consideration for being a participant in the programs offered by the District, I hereby consent and grant to the District the right, without fees, to make and use video tape recordings/still photographs of me, my minor children, and/or dependents in my care, in any manner or form and for any lawful purpose at any time. I waive any right that I may have to review or approve the finished product, or the use to which it may be applied. I release and discharge the District and its employees from any liability to me, my children and/or dependents in my care by virtue of any representation that may occur in making, editing or use of said video tape recordings/still photography.
