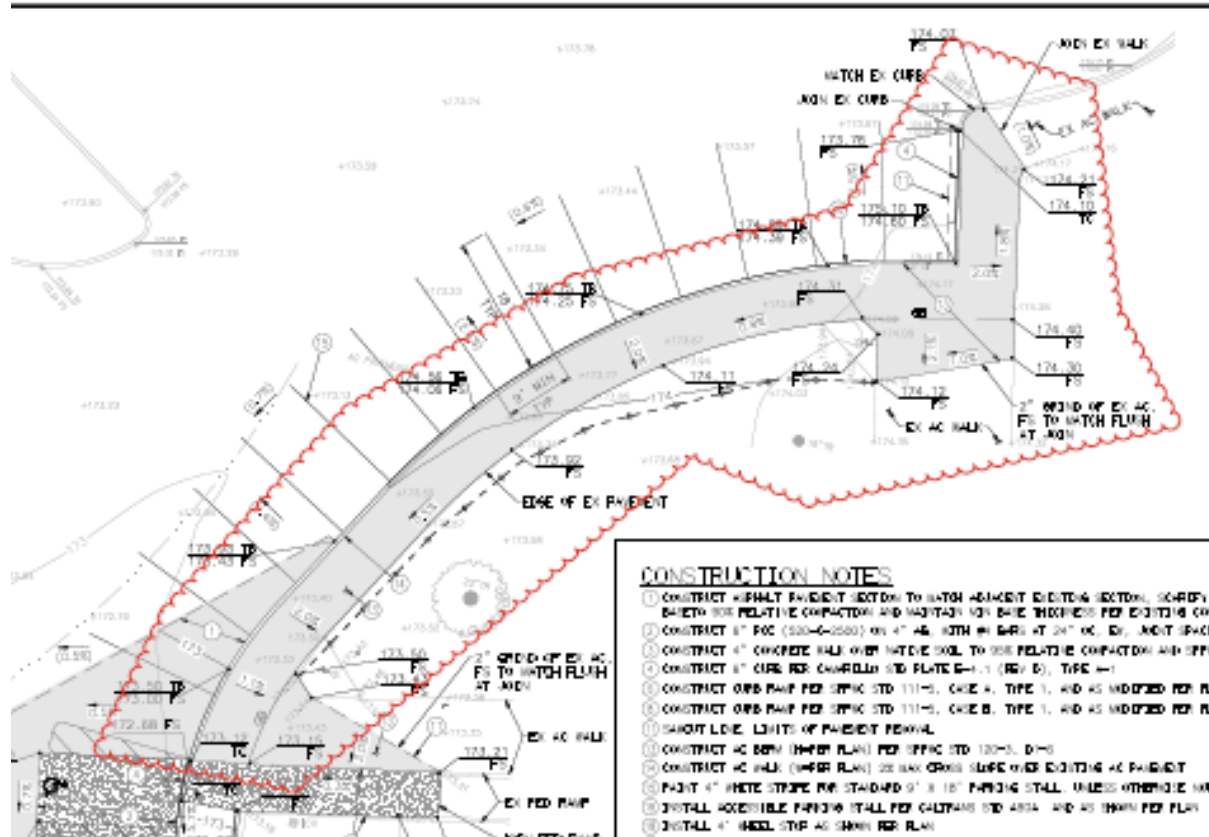
1. Add Alternative Bid for Concrete Curb and Walkway

- 1 CONSTRUCT ASPHALT PAVEMENT SECTION TO MATCH ADJACENT EXISTING SECTION, SCARIFY AND RECOMPACT EXISTING BASE TO 90% RELATIVE COMPACTION AND MAINTAIN MIN BASE THICKNESS PER EXISTING CONDITIONS
- 3 CONSTRUCT 4" CONCRETE WALK OVER NATIVE SOIL TO 95% RELATIVE COMPACTION AND SPPWC STD 112-2
- 4 CONSTRUCT 6" CURB PER CAMARILLO STD PLATE E-4.1 (REV D), TYPE A-1
- 6 CONSTRUCT CURB RAMP PER SPPWC STD 111-5, CASE A, TYPE 1, AND AS MODIFIED PER PLAN
- 7 CONSTRUCT CURB RAMP PER SPPWC STD 111-5, CASE A, TYPE 5, AND AS MODIFIED PER PLAN
- 9 CONSTRUCT CURB RAMP PER SPPWC STD 111-5, CASE D, TYPE 2, AND AS MODIFIED PER PLAN
- 11 SAWCUT LINE, LIMITS OF PAVEMENT REMOVAL
- 12 INSTALL TRUNCATED DOMES AS SHOWN PER PLAN AND SPPWC STD 111-5
- 13 CONSTRUCT AC BERM (H=PER PLAN) PER SPPWC STD 120-3, D1-6
- 14 CONSTRUCT AC WALK (W=PER PLAN) 2% MAX CROSS SLOPE OVER EXISTING AC PAVEMENT
- 15 PAINT 4" WHITE STRIPE FOR STANDARD 9' X 18' PARKING STALL. UNLESS OTHERWISE NOTED PER PLAN
- 16 INSTALL ACCESSIBLE PARKING STALL PER CALTRANS STD A90A AND AS SHOWN PER PLAN
- 17 PAINT 4' WIDE ACCESSIBLE PATH WITH 4" BLUE BORDER AND 4" WHITE DIAGONAL LINES 3 FEET APART ON CENTER
- 18 INSTALL 4' WHEEL STOP AS SHOWN PER PLAN
- 20 INSTALL ACCESSIBLE PARKING SIGN (R99C) AND POST SPPWC STD 180-0
- 21 INSTALL UNAUTHORIZED VEHICLE PARKING SIGN (R100B) AND POST PER SPPWC STD 180-0
